

Mr. Green Lawncare, Inc 2016 Spring Drawing Contest Rules

1. Eligibility

The Contest is subject to federal, state, and local laws and regulations.

2. Sponsor

5. How to Enter

On-Site: This method of entry will be available at Mr. Green Lawncare, Inc, 9200 General Drive, Plymouth, Michigan 48170. Please bring your preprinted postcard to our facility during regular business hours throughout the contest period.

Via Mail: This method of entry will be available for the entire Contest Period. On the preprinted postcard handprint your full name, complete address, phone number (including area code) and mail with proper postage affixed to: 9200 General Drive, Plymouth, Michigan, 48170. All mail-in entries must be postmarked by April 29, 2016 and received by April 30, 2016.

6. Prize Drawing

On or about August 1, 2016, the Sponsor will select potential winners in a random drawing from among all eligible entries received. The odds of being selected depend on the number of entries received. The Sponsor will attempt to notify the potential winner via telephone or email on or about August 2, 2016. If the potential winner cannot be contacted within five (5) days after the date of the first attempt to contact him/her, the Sponsor may select an alternate potential winner in his/her place at random from the remaining non-winning, eligible entries.

7. Winner Notification

The potential winners will be notified by email, mail or phone. Each potential Grand and First Prize winner (parent/legal guardian if a minor in his/her state of residence) will be required to complete, electronically sign and submit a Declaration of Compliance within five (5) days of the date notice or attempted notice is sent, in order to claim his/her prize. The Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the entry process or the operation of the Contest or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner. Any attempt by any person to undermine the legitimate operation of the Contest may be a violation of criminal and civil law, and, should such an attempt be made, the Sponsor reserves the right to seek damages (including attorney's fees) and any other remedies from any such person to the fullest extent permitted by law. Failure by the Sponsor to enforce any provision of these Official Rules shall not constitute a waiver of that provision.

10. Release and Limitations of Liability
